## **Committee Reports:**

    - As of August 19: 824, 1 transfer, 4 new, 15 expired
    - Focusing on membership growth and connections to educational organizations and career development
      - MN Career Development Association with 100 members that function as staff on colleges and universities to assists students on planning careers and navigating career programs
        - Met with executive director and a board member and were encouraging; providing information on connections to make on ways to encourage students or career changes to consider safety as a profession
        - Contacted a couple organizations and heard some



- Gustavus Adolphus: Conference Oct 1 and 2: Sleep Unraveled Mark is understanding what he can do to assist in any way or have an opportunity to get in front of some students
- Private College Career Consortium in February each year at Convention Center and will follow up
- Science Fairs in Mankato that may be an opportunity
- Attended Leadership Development Conference at Denver and shared some feedback on topics that could enhance membership experience

    - 32 students enrolled in Stout program
    - 75% of students are working in the profession in some capacity
    - Classes largely full due to alliances with other programs at Stout
    - With many working in the profession it is difficult to get them to become invovled as a student chapter, but encourages them to become student members



- Student resource projects presented last spring was very beneficial to the students and would like to offer that as a presentation topic again
