March 27th in which Tom Goeltz testified in favor of HF104, a MN House bill to increase penalties for those causing traffic incidents while distracted by a cell phone. MN KARE11 news carried a great summary of the hearing, the bill's progress, and Tom's testimony.

A letter was provided to the Transportation Committee prior to this hearing on behalf of ASSP Northwest Chapter in favor of HF104 and related distracted driving bills. This letter process and presence at the hearings will continue until the bills are passed.
