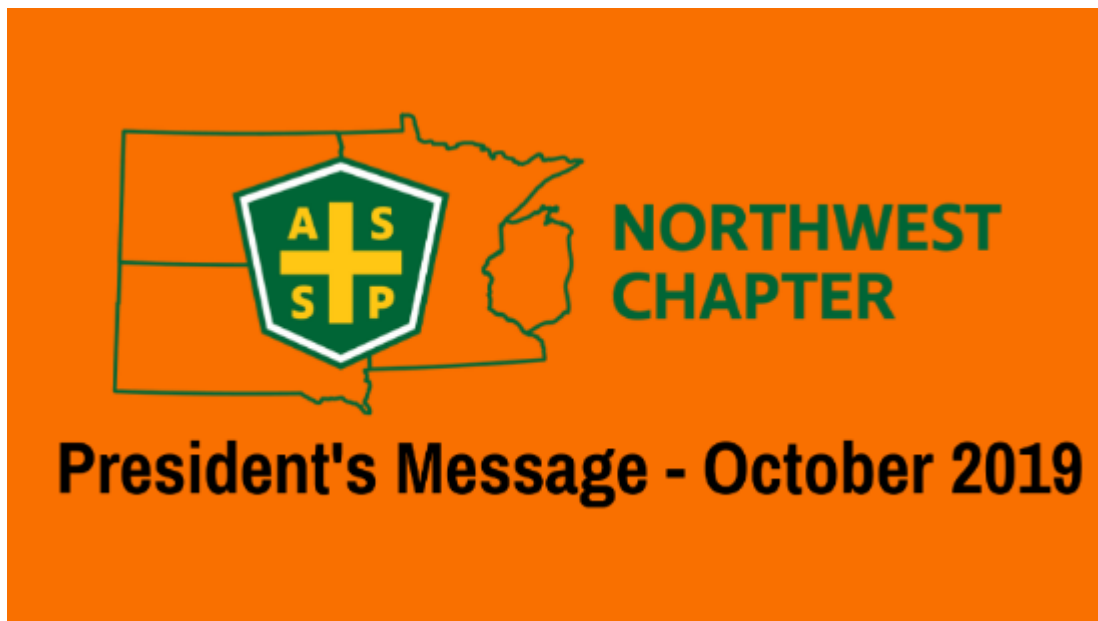

ANSI/ASSP Z10.0 - 2019 Occupational Health and Safety Management Systems

The revised ANSI/ASSP Z10.0-2019 standard is considered a "Blue Print" for the implementation of safety and health management systems and is now available from the American Society of Safety Professionals (ASSP) after recently being approved by the American National Standards Institute (ANSI).
