Approval of Minutes:

- Jenn C emailed the Board the March 8, 2022, meeting minutes
 - Scott H moved to approve the March 8, 2022, meeting minutes; Paul G seconded motion passed unanimously

Treasurer Report:

- Chris F provided an overview on the March 31, 2022, Treasurer Report
 - o Revenue of \$1,325 (dues \$1,325)
 - o Expenses of \$171 (68 renewals \$136, web hosting \$35)
 - o Net income of \$1,154.00; bank balance \$45,997.45
 - Jenn C moved to approve the March 31, 2022, Treasure Report; Scott H seconded

 motion passed unanimously
- 2021-2022 Fiscal Year Wrapped-Up March 31, 2022
 - o Profited \$1,664.42
- 2022-2023 Fiscal Year Proposed Budget
 - o Additional discussion led to:
 - Budgeting \$100 for postage / mailing
 - Keeping placeholder for Special Projects
 - Budgeting \$1,000 for networking budget
 - Meeting Fees were adjusted for September and now reflect \$500 (this also adjusts Lunch/Dinner under Cash Disbursements)
 - o Looking to reduce costs in some area and increase scholarship funding
 - o Refer to spreadsheet for estimated revenue and expenses
 - Total revenue estimated at \$59,490
 - Total expenses estimated \$64,726
 - Expected loss of \$5,236
 - o **Motion 220412a:** Carol K moved to approve the 2022-2023 Budget as modified in our working meeting; Scott H seconded motion passed unanimously

Previous Meeting Business:

- Cary Swenson Memorial Scholarship Fund through ASSP Foundation
 - UMD students will be eligible if they are a Spring student, they would need to show registration and apply before deadline
 - Previous meeting minutes reflected a request in the range of \$2,500-\$5,000 range for donation; this would be a onetime donation from Northwest Chapter, but MN Safety Council needs to raise \$30,000 to be fully funded and realized
 - o Discussion:
 - MN Safety Council has offered up \$5,000 to start the fund
 - Concerns that this limits scholarship to UMD only students
 - There is value in supporting this as the scholarship lasts into the future
 - **Motion 220412b:** Scott H made a motion that the Northwest Chapter pledges a onetime donation of \$1,000 to support the Cary Swenson Memorial Scholarship



Fund; Chris F seconded. Jeff J and Alanna L abstained from voting – motion passed unanimously.

- Discussion around re-naming our Chapter *did not discuss today*
- Challenges of the school programs (UMD, Stout, Whitewater) did not discuss today

Chair Updates

- Chapter Program (Scott H):
 - April 12 Meeting Recap: concluded April program with around 20 participants;
 Scott will get thank you card out and gift
 - o May 10: Speaker is Jill James of Vivid Learning Systems; details are developing
 - o August 4: Boat Cruise on St. Croix River
 - Will try to push to hybrid meeting for September potentially at the Builders Group or 3M Innovation Center

- **Mentoring (Mark N):** Currently working with two individuals on mentorship. Scott H has a potential mentor he may be taking on soon.
