Description:

Slips, trips, and falls make up over 20% of workplace injury costs and the leaked or spilled fluids be a major contributor to those hazards. These “rogue” fluids can come from nearby equipment, production lines or even inclement weather.

Leaks and spills can affect many aspects of your operation and your business. Complying with regulatory requirements from OSHA, EPA and DOT will not only help you avoid fines but give you a guideline for keeping your facility, the surrounding environment, and your employees safe.
