Special Presentation: "A Day Like Any Other – What Columbine, Sandy Hook & Parkland Tragedies Taught Us"

School safety and mental health are top of mind concerns for parents and educators. With few exceptions, schools and communities are faced with the dilemma of how to protect the integrity of the environment where learning takes place amidst a world of increasing violence. The concerns for school safety are not new. The challenges are real.

Rick served as a consultant/trainer for Atlanta Public Schools, U.S. Department of Education, LA Office of the FBI, Association of State Colleges & Universities, National School Boards Association, North Carolina and North Dakota Division of Emergency Management agencies, the Minnesota Office of Emergency Preparedness, and the

Minnesota School Safety Center. Rick is the author of The Complete Crisis Communication Management Manual for Schools (4th edition, 2018).

His greatest achievement is parenting five children and being a "Papa" to KJ and Makynlee Rae.

December Program Overview: Minimizing Risk from Spilled Fluids Through Preparedness & Compliance

Facilitator: Tyler Riewe, Director of Strategic Accounts FyterTech Nonwovens

Northwest Chapter Vice President's Top Five Takeaways:

- 1. Facilities may be overlooking slips, as they are often not tied to a Job Hazard Analysis (JHA)
- 2. Slips, trips, and fall cost: lives, time, money
 - Third leading work-related injury involving days away from work (average of 14 days)
 - 211,640 injuries in 2020 (18% of injuries)
 - Average lost-time worker's compensation claim for slips, trips, and falls = \$48,575
- 3. OSHA 1910.22 contains general requirements for employers as it relates to their walking/working surface conditions

- 4. Workplace and process design can play a major role in reducing the risks of slips, trips, and falls
- 5. Spill Prevention Control and Countermeasures (SPCC) relates specifically to oil, but 'oil' can include a lot of things outside of petroleum-based products (butter, animal byproducts, soybean/plant oil, etc.)
